


The Centre for Strategic Philanthropy

Overview

- The Centre for Strategic Philanthropy (CSP) is a place for givers with a strategic, business-like approach to meet, share, learn and find opportunities to act
- Catalysed by NEXT and with the backing of five founding funders, and seven supporting families, the CSP launched in 2022
- The organisation's proposition is bespoke, and focused on supporting and encouraging individuals and families who wish to approach their giving in a thoughtful way
- Looking forward, the founders of the Centre hope philanthropy within Aotearoa New Zealand will evolve to become more strategic, more collaborative and more impactful

The Centre for Strategic Philanthropy

The Centre for Strategic Philanthropy (CSP) is a place for givers with a strategic, business-like approach to meet, share, learn and find opportunities to act. Catalysed by NEXT and backed initially by five founding funders, the Centre believes that a stronger, more resilient and equitable Aotearoa is possible when good people work together effectively. The CSP aims to catalyse more thoughtful philanthropy for the benefit of New Zealand.

'Annette, Neal and trustees wanted NEXT to be not just a 'doer' of strategic philanthropy, they wanted it to be an inspiration and catalyst for strategic philanthropy in New Zealand. Background

NEXT's aim was to leave a legacy for the land and people of New Zealand. The original strategic plan outlined an intent to deliver a 10-year \$100 million spend down programme, and focus in the areas of education and environment. Beyond this, there was a deeper intent: the Foundation wanted to act as a role model for strategic philanthropy and inspire others to give in a similar way.

THE NEXT APPROACH TO STRATEGIC PHILANTHROPY

- NEXT aimed to transform the ecosystems it chose to focus in
- NEXT invested, partnered, convened and advocated for increased impact in those ecosystems
- NEXT was business-like and learning focused

The NEXT strategic approach included: systems thinking; backing and building strong governance and project management capability and capacity within the organisations it supported; goal setting; measurement – and making changes based on those measurements; organisational capacity building; collaborating for impact; ensuring the good work had a plan for sustainability; and bringing a humble, learner mindset to the work.


WHY A STRATEGIC IMPERATIVE?

There are many complex and varied issues facing Aotearoa New Zealand. These require coordinated solutions across sectors and organisations. Philanthropy is uniquely placed to convene on key issues, act as an 'honest broker', and bring together diverse groups to work towards a common goal. NEXT believed that strategic generosity can amplify impact on some of the nation's critical issues. With this purpose in mind, NEXT catalysed the Centre for Strategic Philanthropy.

'Effective giving in NEXT's view is as much about the non-financial support a giver can provide, as the financial assistance. This can encompass convening, partnering, governance support, capacity building, leveraging relationships – any and all of those things. The strategic approach is a business-like one. There can be a perception about business, that it's only profit driven. In my experience, it is much broader than that. And good business is always founded on good relationships.'

Five founding funders

In 2022 the Centre for Strategic
Philanthropy launched with the support of
five founding funders. Seven others have
subsequently gifted. The founding group
included Biome Trust, Allan & Gill Gray
Philanthropies, NEXT, Whakatupu Aotearoa
Foundation, and JN and HB Williams
Foundation. This consortium wished to
promote and increase strategic philanthropy
within Aotearoa, create a community to
enable sharing and learning, and make a
substantive contribution to the nation.

Motivations for their involvement included:

- A belief in the potential of strategic philanthropy to make a real difference for the country
- To catalyse others to get involved in philanthropy and be strategic in deploying their resources
- To encourage and facilitate joined-up approaches, with the aim of making more impact together in their common interest areas
- To build a community of learning with like-minded givers, who wished to be business-like and guided by evidence
- Respect for NEXT

There are many examples of giving circles overseas which effectively increase collaboration. New Zealand is small, so that can happen naturally and we can be more intentional about collaboration. Philanthropic communities often duplicate efforts, like local food resilience, early childhood, and pest eradication. Creating more independent, third-party communities and networks can sharpen our strategic lens, so that others don't need to manage all of this in-house.'

The Centre for Strategic Philanthropy offers:

- A place for individuals and families who wish to be businesslike in their generosity to learn, connect with others, and (if they wish), collaborate in areas of common interest
- Provision of tailored support and advice in a discreet, high trust environment, respecting that for many this is not their core business and their time is valuable
- Recognition that each giver is different some may wish to give financially, others may wish to provide non-financial support (or a combination of both)
- Access to the lessons from the NEXT Foundation's experience and to the learnings of other local foundations also operating strategically, high quality research (including sector reviews) and international evidence
- Referrals to other sector organisations. For instance,
 Philanthropy New Zealand, regional community foundations,
 and The Gift Trust. Bill Kermode shares, 'These relationships are affiliative, constructive and complementary. We all want to see a better Aotearoa New Zealand'
- Support to give with impact, alongside a community of others of like mind

Looking ahead ten years, the founding funders share their hopes for how philanthropy within New Zealand will have evolved.

The aspiration existed for a strategic and uniquely Aotearoa model of philanthropy:

- The sector will be more strategic and New Zealand will be leading on key issues
- Collaboration will have increased and will be making a manifest difference in multiple cause areas
- Philanthropy will encapsulate the best of the world and the best of Aotearoa, including learning from and partnering with iwi Māori
